Large boarding house / Co-Living projects used to require BASIX in the past. But the requirements have been changed 2-3 years ago, and these type of Class 3 development are no longer BASIX development.

Please see below the relevant extract and link to the planning portal.

It is no longer mandatory to obtain a BASIX certificate for the erection of a new large boarding house, or alterations to an existing large boarding house, as this development is no longer BASIX development.

Specifically, the definition of a BASIX building in the <u>Environmental Planning and</u> <u>Assessment Regulation 2021</u> excludes a boarding house, hostel or co-living housing that accommodates more than 12 residents, or has a gross floor area exceeding 300 square metres.
