Description of proposal

The works involve widening the upper parts of the snowmaking pond channel through excavation and removal of alluvium and associated vegetation and will be timed to coincide with the periods of low flow.

Nominated Integrated Development

The proposal is classed as integrated development under the *Environmental Planning and Assessment Act 1979* as approval is required from the Department of Climate Change, Energy, the Environment and Water (DCCEEW) under section 91 of the *Water Management Act 2000* and consultation with Department of Primary Industries and Regional Development (DPIRD) – Fisheries under section 201 of the *Fisheries Management Act 1994*.

About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development. The Department of Planning, Housing and Infrastructure (the Department) has received a development application for the abovementioned proposal.

The application and accompanying documents are on exhibition from Friday 1 August 2025 until Thursday 28 August 2025. You can view these documents online at State Development Applications.

At the time of publishing this advertisement, the Minister for Planning has not directed that a public hearing should be held.

Have your say

- your name and address
- the name of the application and the application number
- a statement on whether you 'support' or 'object' to the proposal or if you are simply providing comment
- the reasons why you support or object to the proposal

- a declaration of any reportable political donations you have made in the last two years (visit <u>Donations</u> and <u>Gifts Disclosure</u> or phone 1300 305 695 to find out more)
- an acknowledgement that you accept the department's disclaimer and declaration.
