Description of proposal

Construction of a new mountain bike trail called the Section 44 trail, a technical/ intermediate to advanced jump trail focusing on highspeed technical sections while incorporating jumps built into the natural terrain

The proposal is classed as integrated development under the *Environmental Planning and Assessment Act 1979* as approval is required from the Department of Climate Change, Energy, the Environment and Water (DCCEEW) under section 91 of the *Water Management Act 2000*
