ONGOING MANAGEMENT – Stage 2(C)

Our on site supervisor will monitor that waste is placed in the appropriate facilities provided.

During our construction process we have fortnightly to monthly cleans throughout the build, depending on when the bags need replacing.

These will accommodate both mixed and masonry waste as Bingo Industries reclaims materials.

As well as the set site cleans, our on site supervisor will further monitor the waste levels to ensure that they are emptied as necessary.
