Have your Say - Proposed Amendments to Development Contributions Plan

## Fairfield Direct (Section 7.11) Development Contributions Plan 2011 Draft Amendment No.12

At its meeting held on 9 February 2021, Council's Outcomes Committee resolved to publicly exhibit amendments to the Fairfield Direct (Section 7.11) Development Contributions Plan 2011. The public exhibition is in accordance with Clause 18 of the Environmental Planning and Assessment Regulation 2000.

The purpose of draft Amendment No.12 is to:

- reflect the land acquisition schedule and contribution rate changes resulting from Fairfield Local Environmental Plan 2013 Amendment No.38 that rezoned certain residential land in Fairfield, Fairfield Heights, Fairfield East and Villawood for higher densities and public recreation to create 8 new neighbourhood parks;
- 2. amend the land acquisition works schedule and contribution rates for the Fairfield and Villawood subdistricts;
- 3. amend relevant text to incorporate new standards for open space provision reflected in the Western City District Plan 2018 including proximity to open space; and
- 4. make minor amendments to update references to sections in the EP&A Act 1979, environmental planning instruments, planning policies and local strategies.

The draft amendment is on public exhibition between Wednesday, 17 February 2021 to Wednesday 17 March 2021 inclusive.
