ATTACHMENT E-Council's Response to the Public Listening Sessions

On 18 February 2016, an independent facilitator hosted two Public Listening Sessions. The purpose of the sessions was to provide an alternative forum for members of the public to have their say on the Draft Local Area Plans, within an independent forum, and to verbally provide their feedback to Council in front of members of their community. The table below summarises Council's response to the matters raised in the Public Listening Sessions that are specific to the South West Local Area Plan.

The Residential Frame precinct also avoids rezoning properties that have direct vehicle access to Henry Lawson Drive.

This distance provides an adequate level of containment for a centre of this size, and is an appropriate fit within the centres hierarchy. There is the potential for the Residential Frame precinct to be a place of well–proportioned, human scale buildings and streets to contribute to the sense of comfort and village feel. The intended outcome is to provide a mix of low and medium–rise living choices within a short walking distance of the railway station, commercial core and local services. In terms of infrastructure, Council consulted government agencies. The government agencies such as Transport for NSW, Roads & Maritime Services, Ausgrid, NSW Health–South Western Sydney Local Health District, Sydney Water and Department of Education did not identify any significant impact on services as a result of the proposed changes in the Local Area Plan.
