### Planning proposal to amend the Woollahra Local Environmental Plan 1995

I am writing in response to your Council's letter dated 21 December 2012 requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") in respect of the planning proposal to amend the Woollahra Local Environmental Plan (LEP) 1995 to adopt the standard instrument LEP definitions for building height and existing ground level.

As delegate of the Minister for Planning and Infrastructure, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

I understand that the Minister has written to Councillor Andrew Petrie encouraging Woollahra Municipal Council to finalise its standard instrument LEP as early in 2013 as possible. The Department of Planning and Infrastructure remains committed to assisting Council to achieve this outcome. Council should contact the relevant regional planning team of the department should it require any assistance in fast tracking work on its standard instrument LEP.

The Minister delegated his plan making powers to councils in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending LEP is to be finalised within 9 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the department for administrative purposes

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under s54(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

# **Gateway Determination**

**Planning proposal (Department Ref: PP\_2013\_WOOLL\_001\_00)**: to amend the definition of for building height and existing ground level in the Woollahra LEP 1995.

I, the Director General, Department of Planning and Infrastructure as delegate of the Minister for Planning and Infrastructure, have determined under section 56(2) of the EP&A Act that an amendment to the Woollahra Local Environmental Plan (LEP) 1995 to adopt the standard instrument LEP definitions for building height and existing ground level should proceed subject to the following conditions:

- 1. Given that Councils legal advice is confidential and Council does not wish to make this advice public, the planning proposal is to be amended to remove any reference to confidential legal advice, prior to undertaking public exhibition:
- 2. Community consultation is required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") as follows:
  - (a) the planning proposal is classified as low impact as described in *A Guide to Preparing LEPs (Department of Planning & Infrastructure 2012)* and must be made publicly available for **14 days**; and
  - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Department of Planning & Infrastructure 2012).
- 3. Consultation is not required with public authorities under section 56(2)(d) of the EP&A Act.
- 4. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 5. The timeframe for completing the LEP is to be **9 months** from the week following the date of the Gateway determination.
