**PLANNING PROPOSAL DRAFT KEMPSEY LEP 2013 AMENDMENT NO 24 – TO AMEND SCHEDULE 1 ADDITIONAL PERMITTED USES AND THE ADDITIONAL PERMITTED USES MAP TO PERMIT (WITH DEVELOPMENT CONSENT) THE LAND USE *HIGHWAY SERVICE CENTRES* AT 600 MACLEAY VALLEY WAY, SOUTH KEMPSEY – REQUEST FOR GATEWAY DETERMINATION**

Reference is made to the above Planning Proposal.

On 26 June 2018 Council resolved:

- 1. That the planning proposal which seeks to permit the land use highway service centre at 600 Macleay Valley Way, South Kempsey, be submitted to the Minister for Planning for Gateway consideration pursuant to section 3.34 of the Environmental Planning and Assessment Act 1979.*
- 2. That the Secretary of the Department of Planning and Environment be requested to issue Council with written authorisation to exercise plan making delegations in relation to this proposal.*
- 3. Subject to the Gateway determination, community consultation for the planning proposal be undertaken.*

In accordance with this Council Resolution, consideration for a Gateway Determination is requested.

The intent of the Planning Proposal is to amend *Schedule 1 Additional permitted uses* and the *Additional Permitted Uses Map – Sheet APU\_011B* in KLEP 2013 to permit (with development consent) the land use *Highway Service Centres* at the subject site to provide the opportunity for a 2<sup>nd</sup> highway service centre in the vicinity of the South Kempsey interchange. The subject land is zoned RU2-Rural Landscape with a minimum lot size of forty (40) hectares.

Please find enclosed a disc containing the Planning Proposal, Council Report associated with the proposed Amendment, and a completed information checklist.

It is also requested that the Secretary issue Council with written authorisation to exercise its plan making delegations in relation to this proposal. The completed Evaluation Criteria for the Delegation of Plan Making Functions form is also on the disc.

In addition, an indicative timeframe for completion has been provided in the table below.
