Summary

A site specific Planning Proposal has been received for Lot 4 DP 264133, being known as 280 Burroughs Crossing Road, Oberon to enable a Function Centre to be undertaken on the land.

Comment

FOLLOWING is the Planning Proposal that has been prepared for Lot 4 DP 264133 being known as 280 Burroughs Crossing Road, Oberon to justify departure from prohibitions relating to Function Centres in the RU1 Primary Production zone.

The preparation of a Planning Proposal is the first step in preparing a Local Environmental Plan (LEP).

A Gateway determination is issued by the Minister (or delegate). It specifies whether a Planning Proposal is to proceed and if so, in what circumstances. The Gateway determination confirms the information (which may include studies) and consultation is adequate prior to making an LEP.

The Planning Proposal seeks to amend the Oberon Local Environmental Plan 2013 (OLEP 2013) by the inclusion of an 'additional permitted use' under Schedule 1 to enable, subject to development consent a Function Centre on the subject land.

As a result of OLEP 2013 other enquiries have been received relating to Function Centres in the RU1 zone. This proposal is the first however to provide justification for Councils consideration.

It is considered that the planning proposal can be supported in this instance.
