Planning proposal [PP\_2018\_BATHU\_001\_00] to amend Bathurst Regional Local Environmental Plan 2014 - Minor Amendments to Zone Boundaries, 240 Limekilns Road, Kelso

I am writing in response to Council's request for a Gateway determination under section 3.34 of the *Environmental Planning and Assessment Act 1979* (the Act) in respect of the planning proposal for minor amendments to zone boundaries of Lots 2 and 3, DP1233661, and Lot 1 DP176203 at 240 Limekilns Road, Kelso.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination (**Attachment 1**).

I have also agreed, as delegate of the Secretary, the planning proposal's inconsistencies with section 9.1 Directions (1.2 Rural Zones, 1.5 Rural Lands and 3.1 Residential Zones) are justified in accordance with the terms of the Directions. No further approval is required in relation to these Directions.

Plan making powers were delegated to Councils by the Minister in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation (**Attachment 2**) to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within 12 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office (<a href="mailto:parliamentary.counsel@pco.nsw.gov.au">parliamentary.counsel@pco.nsw.gov.au</a>) 10 weeks prior to the projected publication date.

A copy of the request should be forwarded to the Department of Planning and Environment (westernregion@planning.nsw.gov.au) for administrative purposes.

All related files for LEP Amendment, including PDF Maps, Map Cover Sheet, planning proposal document and GIS Data, if available, must be submitted to the Department via the Planning Portal Website at <a href="https://www.planningportal.nsw.gov.au/planning-tools/online-submission-planning-data">https://www.planningportal.nsw.gov.au/planning-tools/online-submission-planning-data</a>. To submit the data, Council is required to create an account and log in using these details.

In accordance with "A guide for the preparation of local environmental plans", an authorised plan making reporting template (**Attachment 3**) is enclosed for Council's information. Table 2 of the attachment is to be completed and included in Council's section 3.36 submission when requesting the planning proposal be finalised.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 3.32(2)(d) of the Act if the time frames outlined in this determination are not met.

### **Gateway Determination**

Planning proposal (Department Ref: PP\_2018\_BATHU\_001\_00): for minor amendments to zone boundaries, 240 Limekilns Road, Kelso.

I, the Director Regions, Western Region at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 3.34(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the Bathurst Regional Local Environmental Plan 2014 (LEP) for minor amendments to zone boundaries, 240 Limekilns Road, Kelso should proceed subject to the following conditions:

- 1. Community consultation is required under sections 2.22 and 3.34(2)(c) of the Act as follows:
  - (a) the planning proposal must be made publicly available for a minimum of **28** days; and
  - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Department of Planning & Environment August 2016).

No consultation is required with public authorities under section 3.34(2)(d) of the Act.

- 2. A public hearing is not required to be held into the matter by any person or body under section 3.34(2)(e) of the Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 3. Prior to submission of the planning proposal under section 3.36 of the Act, the final LEP maps must be prepared and be compliant with the Department's 'Standard Technical Requirements for Spatial Datasets and Maps' 2015.
- 4. Prior to submission of the planning proposal under section 3.36 of the Act, Council is to ensure that the planning proposal satisfies the requirements of State Environmental Planning Policy (SEPP) 55 Remediation of Land to demonstrate that the land is suitable for rezoning the land to the proposed RE1 Public Recreation zone.
- 5. The time frame for completing the LEP is to be 12 months from the date of the Gateway determination.
