## Planning proposal to amend Richmond Valley Local Environmental Plan 2012

I refer to your Council's correspondence dated 21 December 2016 in relation to planning proposal PP\_2013\_RICHM\_006\_00 for rezoning of land for rural residential purposes at Ellems Bridge Road, Piora.

I note Council's decision to request discontinuation of this matter under section 58(4) of the Environmental Planning and Assessment Act 1979.

As delegate of the Minister for Planning, I have now determined the planning proposal should not proceed and to alter the conditions of the Gateway determination dated 17 December 2013 (as altered). The Alteration of the Gateway Determination is enclosed.

## **Gateway Determination**

## Planning proposal (Department Ref: PP\_2013\_RICHM\_006\_00)

I, the Deputy Secretary, Planning Services at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act* 1979 (the Act) to alter the Gateway determination dated 17 December 2013 (as altered) for the proposed amendment to the *Richmond Valley Local Environmental Plan* 2012 as follows:

1. Delete paragraph 2:

"I, the Deputy Director General, Growth Planning and Delivery at the Department of Planning and Infrastructure as delegate of the Minister for Planning and Infrastructure, have determined under section 56(2) of the EP&A Act that an amendment to the Richmond Valley Local Environmental Plan (LEP) 2012 to rezone Lot 1 and part of Lot 2 at Ellems Bridge Road from RU1 Primary Production to R5 Large Lot Residential should proceed subject to the following conditions:"

and replace with a new paragraph 2:

"I, the Deputy Secretary, Planning Services at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the Richmond Valley Local Environmental Plan (LEP) 2012 to rezone Lot 1 DP 449328 and part of Lot 2 DP 1170052 Ellems Bridge Road, Piora, from RU1 Primary Production to R5 Large Lot Residential should not proceed."

2. Delete conditions 1 to 7.
