Request for Planning Proposal not to proceed – PP_2014_AUBUR_006_00 Berala Village

Alteration of Gateway Determination

Planning Proposal (Department Ref: PP 2014 AUBUR 006 00)

I, the Deputy Secretary, Planning Services at the Department of Planning and Environment as delegate of the Greater Sydney Commission, have determined under section 56(7) of the Environmental Planning and Assessment Act 1979 to alter the Gateway determination dated 17 December 2014 (as since altered) for the proposed amendment to the Auburn Local Environmental Plan 2010 as follows:

1. Delete paragraph 1:

"I, the Director, Metropolitan (Parramatta) at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the Environmental Planning and Assessment Act 1979 (EP&A Act) that an amendment to rezone certain land in Berala Village should proceed subject to the following conditions:"

and replace with:

"I, the Deputy Secretary, Planning Services at the Department of Planning and Environment as delegate of the Greater Sydney Commission, have determined under section 56(2) of the Environmental Planning and Assessment Act 1979 (the Act) that an amendment to rezone certain land in Berala Village should not proceed."

2. Delete Conditions 1 to 6.
