Planning Proposal 3 – Administrative Review to rectify minor errors

At its meeting of 15 December 2010, Council resolved as follows with respect to a proposed amendment to Bellingen Local Environmental Plan 2010.

- (1) That Council resolve to proceed with Planning Proposal No 3 in accordance with the detail contained in this report.
- (2) That Council forward the proposal to the Minister for Planning for a Gateway Determination, with a request that the Community Consultation process be dispensed with due to the administrative nature of the proposal.

A copy of the report to Council and the accompanying map series is attached. The report describes the proposed amendment in detail and addresses all relevant matters, including the Director Generals requirements for the justification of all planning proposals.

Pursuant to the provisions of Section 56 of the Environmental Planning & Assessment Act 1979 (the Act), the Planning Proposal is hereby forwarded to the Minister for a Gateway Determination.

Please also note that given the administrative nature of the Planning Proposal, Council is requesting that the community consultation requirement stipulated by Section 57 of the Act be dispensed with in accordance with the facilitative provisions contained within Section 73A of the Act (*Expedited amendments of environmental planning instruments*).
