RE: GATEWAY DETERMINATION FOR DRAFT LIVERPOOL LOCAL ENVIRONMENTAL PLAN (AMENDMENT No. 9)

In accordance with Clause 56 of the Environmental Planning and Assessment Act 1979, Council is forwarding a planning proposal for Draft Liverpool Local Environmental Plan 2008 (Amendment No. 9) for gateway determination.

Council received an application from the owner of 441 Hoxton Park Road Hinchinbrook seeking the rezoning of part of this site from R2 Low Density Residential to B1 Neighbourhood Centre. The rezoning will allow for the development of a small retail centre which will service the surrounding residents in Hinchinbrook and eastbound traffic along Hoxton Park Road.

At its meeting on 19 April 2010, Council resolved to:

- Pursue an amendment to the Liverpool Environmental Plan 2008 to rezone Part of 1. 441 Hoxton Park Road Hinchinbrook from R2 Low Density Residential to B1 Neighbourhood Centre, and make consequential amendments to the floor space ratio, height of buildings and minimum lot size Liverpool Local Environmental Plan 2008 maps to facilitate the neighbourhood centre development.
- Forward the Planning Proposal to the Minister for Planning seeking Gateway 2. Determination in accordance with Section 56 of the Environmental Planning and Assessment Act 1979.

A copy of the Planning Proposal and Council report for Draft Liverpool Local Environmental Plan 2008 (Amendment No. 9) is enclosed for your consideration and gateway determination. A timely response to this matter would be much appreciated.
