## 1 Name of Plan

This Plan is Campbelltown (Urban Area) Local Environmental Plan 2002 (Amendment No 23).

- (b) Lot 12, DP 700701 and part of Lot 13, DP 700702, known as Nurra Reserve, at Dickens Road, Ambarvale,
- (c) part of Lot 33, DP 700703, known as Julius Reserve, at Julius Road, Rosemeadow.

#### [1] Clause 66

Insert after clause 65:

#### 66 Development on land at Nurra Reserve, Ambarvale

- This clause applies to land at Nurra Reserve, Ambarvale, being Lots 12, DP 700701 and part of Lot 13, DP 700702, as shown (1)edged heavy black on Sheet 2 of the map marked "Campbelltown (Urban Area) Local Environmental Plan 2002 (Amendment No 23)".
- (2) Development consent must not be granted to development on land to which this clause applies unless the Council has considered the impact of the development on the preservation of trees and other vegetation on the land.
