I am writing to advise that Council considered the progress of the above mentioned planning proposal at its Ordinary Meeting held on 25 July 2013 and resolved as follows (Minute No 250713/13):

- 1. That Council endorses the insertion of four new subdivision provisions relating to boundary adjustment subdivision, residual lots and environmental protection zoned lots within the Ballina Local Environmental Plan 2012.
- 2. The Council proceed to submit the planning proposal, BSCPP 13/001 Subdivision Provisions, to the NSW Department of Planning and Infrastructure for finalisation.

In accordance with Council's resolution, please find enclosed the final planning proposal for the Department's review and finalisation. The planning proposal has been updated since it was submitted for Gateway determination to incorporate the requirements of this determination and the outcomes of the community and agency engagement process. Your attention is drawn to the post-exhibition adjustments outlined within the planning proposal. Council would appreciate these adjustments being taken into consideration during the finalisation process.

Further, Council would also like to discuss the processing of the provisions that relate to 'E' zones in relation to the Department's 'E' zone review and ensuring a practical outcome in relation to the proposed clauses.

Council requests that the Department proceeds to finalise the LEP amendment for implementation. Please note, there are no changes to mapping required in conjunction with this LEP amendment.
