Liverpool Local Environmental Plan 2008 (Amendment No 52) - Revised **Gateway Determination**

I refer to your request dated 29 June 2016 for a revised Gateway determination for Liverpool Local Environmental Plan 2008 (draft Amendment No 52).

I note Council intends to revise the planning proposal to remove a site known as 77-83 Moore Street (Lot 1 DP 628824) and 193 Macquarie Street (Lot 2 DP 1189772), Liverpool.

Revised Gateway Determination

I, the Director, Sydney Region West, Planning Services, at the Department of Planning and Environment, as delegate of the Greater Sydney Commission, have determined under section 56(7) of the *Environmental Planning and Assessment Act* 1979, to alter the Gateway determination dated 24 September 2015 (as amended), for the proposed amendment to *Liverpool Local Environmental Plan 2008* as follows:

Delete:

Planning proposal (Department Ref: PP_2015_LPOOL_003_00): to amend Liverpool Local Environmental Plan 2008 concerning rezoning of part of Liverpool City Centre Commercial Core from B3 Commercial Core to B4 Mixed Use, to allow additional permissible development controls on Liverpool Hospital Campus site and some existing B4 Mixed Use zones adjoining the city centre, and amend development standards corresponding to the proposed changes in land use and built form.

And replace with:

Planning proposal (Department Ref: PP_2015_ LPOOL _003_00): to amend Liverpool Local Environmental Plan 2008 concerning rezoning part of Liverpool City Centre Commercial Core from B3 Commercial Core, except for land known as 77-83 Moore Street (Lot 1 DP 628824) and 193 Macquarie Street (Lot 2 DP 1189772), to B4 Mixed Use, to allow additional permissible development controls on Liverpool Hospital Campus site and some existing B4 Mixed Use zones adjoining the city centre, and amend development standards corresponding to the proposed changes in land use and built form.
