Alteration of Gateway Determination

Planning proposal (Department Ref: PP_2015_WOLLY_003_00) (Attached Dual Occupancies in Rural Zones and Clarification of Sewer Requirements)

I, the Director, Sydney Region West, Planning Services, at the Department of Planning and Environment as delegate of the Greater Sydney Commission, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979 ("*EP&A Act") to alter the Gateway Determination dated 22 June, 2015, for the proposed amendment to the *Wollondilly Local Environmental Plan 2011* by:

1. Delete:

Condition (1) "Council is to amend the planning proposal to facilitate the exclusion of attached dual occupancies from clause 7.1(3) of Wollondilly Local Environmental Plan 2011 in rural zones and Zone E4 Environmental Living through an appropriate amending clause."

2. Delete:

Condition "5"

And replace with:

A new condition 5 "The timeframe for completing the LEP is by 29 December 2016".

3. Amend:

Condition "2" to include public authority:

- o "Sydney Water"
- 4. Re-label:

Conditions "2-5" to "1-4".
