## Planning Proposal (Department Ref: PP\_2013\_NAMBU\_002\_00)

I, the Acting Director Regions, Northern at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979* (the Act) to alter the Gateway determination dated 10 July 2013 (as since altered) for the proposed amendment to the Nambucca Local Environmental Plan 2010 as follows:
