# **Alteration of Gateway Determination**

## Planning proposal (Department Ref: PP 2013 THILL 006 00)

I, Executive Director, Regions, at the Department of Planning and Environment as delegate of the Greater Sydney Commission, have determined under section 56(7) of the Environmental Planning and Assessment Act 1979 (the Act) to alter the Gateway determination dated 24 June 2013 (as since altered) for the proposed amendment to The Hills Local Environmental Plan 2012 as follows:

### 1. Delete paragraph 1:

"I, the Deputy Director General, Planning Operations and Regional Delivery at the Department of Planning and Infrastructure as delegate of the Minister for Planning and Infrastructure, have determined under section 56(2) of the EP&A Act that an amendment to The Hills Local Environmental Plan (LEP) 2012 to rezone Bella Vista Farm at Elizabeth Macarthur Drive, Bella Vista from RE1 Public Recreation to B7 Business Park should proceed subject to the following conditions:"

### and replace with:

"I, the Executive Director, Regions, at the Department of Planning and Environment as delegate of the Greater Sydney Commission, have determined under section 56(2) of the Environmental Planning and Assessment Act 1979 (the Act) that an amendment to The Hills Local Environmental Plan (LEP) 2012 to rezone Bella Vista Farm at Elizabeth Macarthur Drive, Bella Vista from RE1 Public Recreation to B7 Business Park should not proceed."

2. Delete Conditions 1 to 6.
