Parramatta Local Environmental Plan 2011 (Amendment No. 20)

I refer to Council's submission under the *Environmental Planning and Assessment Act 1979* (the Act), requesting the Greater Sydney Commission make Parramatta Local Environmental Plan 2011 (Amendment No. 20) (the Plan).

I note the changes made to the Planning Proposal by Council and have decided, as delegate of the Greater Sydney Commission, that in accordance with s56(7) of the Act, an alteration of the Gateway determination and further community consultation is not necessary in this instance.

I am pleased to advise that as the Commission's delegate, I have considered Council's post exhibition report and the Department's finalisation report, and made the Plan under section 59(2) of the Act, and under section 34(5) it will take effect when published on the NSW Legislation website.

In making the Plan I have deferred the proposed amendments to land at 51 and 53A Marion Street, Harris Park under section 59(3) of the Act. I have deferred this land following consideration of representations made by the landowners and to allow Council to further investigate and consult the landowners regarding its intentions at the site.

A complete list of properties removed from the final Plan, including those removed by Council in response to submissions, is enclosed for your information. I note these sites have been removed to allow Council to investigate these sites further. I encourage Council to contact the Department to discuss the requirements for any future planning proposal if it is seeking to amend the planning controls that apply to any of these sites.
