Various Planning Proposals – Alteration of Gateway determinations

- 66 Phillip Street, Parramatta (PP_2016_PARRA_012_00); and
- 180 George Street, Parramatta (*PP_2016_PARRA_016_00*).

Alteration of Gateway Determination

Planning Proposal (Department Ref: PP_2016_PARRA_007_00)

I, the Executive Director Regions, Planning Services, as delegate of the Greater Sydney Commission, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979* (the Act) to alter the Gateway determination dated 17 June 2016 for the proposed amendment to the *Parramatta Local Environmental Plan 2011* as follows:

1. Delete:

and replace with:

a new condition 4

- 122 Wigram Street, Harris Park (PP_2016_PARRA_006_00);
- 2-10 Phillip Street, Parramatta (PP_2016_PARRA_010_00);
- 66 Phillip Street, Parramatta (PP_2016_PARRA_012_00); and
- 180 George Street, Parramatta (PP_2016_PARRA_016_00).

Each public authority is to be provided with a summary sheet of each of the planning proposals listed above, a copy of (or a website link to) the Parramatta CBD Planning Strategy and any relevant supporting material prepared for the Strategy."
