## Liverpool Local Environmental Plan 2008 (Amendment No 51) – Revised Gateway Determination

I refer to your letter dated 10 September 2015 requesting a revised Gateway determination for Liverpool Local Environmental Plan 2008 (Amendment No 51).

I note Council has revised the planning proposal as a consequence of consultation with the Commonwealth Department of Infrastructure and Regional Development (DIRD) as required in condition No. 5 of Gateway determination issued on 22 May 2015.

I also note the revised planning proposal has amended the existing clause 7.17 Development in flight paths to reflect the Commonwealth legislative requirements to protect the air space as requested by the DIRD. The DIRD has confirmed subject to Council having this clause in the planning proposal it has no issues and gives permission for Council to proceed to exhibition in accordance with the NSW Minister's 117 Direction 3.5 Development Near Licensed Aerodromes, paragraph (4)(d).

The planning proposal is considered to be consistent with the requirements of the Minister's Section 117 Direction 3.5 Development Near Licensed Aerodromes and no further consultation with DIRD is necessary.

As delegate of the Minister for Planning, I have agreed to the proposed changes and revised the Gateway determination issued on 22 May 2015 for PP\_2015\_LPOOL\_001\_00, as attached.

## Delete:

**Planning proposal (Department Ref: PP\_2015\_LPOOL\_001\_00)**: to amend draft Liverpool Local Environmental Plan 2008 to rezone 133 Bigge Street, 26-28 Elizabeth Street and 148 George Street, Liverpool from B3 Commercial Core to B4 Mixed Use and associated amendments including the proposed amendment to Clause 7.17 of the Liverpool LEP 2008 to incorporate Commonwealth legislative requirements for protection of air space.
