Planning Proposal PP_2016_BALLI_002_00 – Alteration of Gateway Determination – Discontinuation of Planning Proposal

I refer to your letter of 3 November 2017 requesting the discontinuation of planning proposal PP_2016_BALLI_002_00, which proposed the rezoning of land at Stoneyhurst Drive, Lennox Head.

Planning Proposal (Department Ref: PP_2016_BALLI_002_00)

I, the Executive Director, Regions at the Department of Planning and Environment, as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979 (the Act)* to alter the Gateway determination dated 26 May 2016 for the proposed amendment to the Ballina Local Environmental Plan 2012 as follows:

1. Delete paragraph 2:

"I, the Acting Director Regions, Northern at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the Ballina Local Environmental Plan (LEP) 2012 to rezone land at Stoneyhurst Drive, Lennox Head to enable it to be developed for residential purposes should proceed subject to the following conditions:"

and replace with:

"I, the Executive Director, Regions at the Department of Planning and Environment, as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the Ballina Local Environmental Plan (LEP) 2012 to rezone land at Stoneyhurst Drive, Lennox Head to enable it to be developed for residential purposes should not proceed."

2. Delete conditions 1 to 6.
