Planning proposal to amend Ballina Local Environmental Plan 2012

I am writing in response to your Council's letter dated 10 May 2016 requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 (the Act) in respect of the planning proposal to rezone land at Stoneyhurst Drive, Lennox Head to enable it to be developed for residential purposes.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

I have also agreed, as delegate of the Secretary, the planning proposal's inconsistencies with S117 Directions 1.2 Rural Zones, and 5.3 Farmland of State and Regional Significance on the NSW Far North Coast are justified in accordance with the terms of the directions. No further approval is required in relation to these Directions.

Council may still need to obtain the agreement of the Department's Secretary to comply with the requirements of S117 Directions 2.1 Environmental Zones, 2.3 Heritage Conservation and 3.5 Development Near Licensed Aerodromes. Council should ensure this occurs prior to the plan being made.

Plan making powers were delegated to councils by the Minister in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within 12 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet

these commitments, the Minister may take action under section 54(2)(d) of the Act if the time frames outlined in this determination are not met.

Gateway Determination

Planning proposal (Department Ref: PP_2016_BALLI_002_00): to rezone land at Stoneyhurst Drive, Lennox Head to enable it to be developed for residential purposes.

- I, the Acting Director Regions, Northern at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the Ballina Local Environmental Plan (LEP) 2012 to rezone land at Stoneyhurst Drive, Lennox Head to enable it to be developed for residential purposes should proceed subject to the following conditions:
- 1. Prior to community consultation the following site investigations are to be undertaken and included with the planning proposal for community consultation:
 - (a) European and aboriginal heritage;
 - (b) Ecological assessment;
 - (c) Geotechnical assessment;
 - (d) Land contamination;
 - (e) Land use conflict:
 - (f) Mosquito hazard;
 - (g) Road noise impacts;
 - (h) Engineering, infrastructure and services and stormwater management;
 - (i) Traffic impacts;
 - (j) Obstacle limitation surface and ANEF assessment; and
 - (k) Coastal zone and visual amenity impacts assessment.
- 2. Once the site investigations and consultation with the relevant Commonwealth aviation authorities are completed, and prior to community consultation, Council is to review the consistency of the proposal with S117 Directions 2.1 Environmental Zones, 2.3 Heritage Conservation and 3.5 Development Near Licensed Aerodromes, and amend the planning proposal if necessary. The agreement of the Secretary of the Department of Planning and Environment is to be obtained for any inconsistency with these directions prior to the plan being made.
- 3. Community consultation is required under sections 56(2)(c) and 57 of the Act as follows:
 - (a) the planning proposal is classified as low impact as described in A Guide to Preparing LEPs (Department of Planning and Infrastructure 2013) and must be made publicly available for a minimum of 14 days;
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of *A Guide to Preparing LEPs* (Department of Planning and Infrastructure 2013); and

- (c) Any mapping material must meet the specifications in the current Standard Technical Requirements for Spatial Datasets and Maps (Department of Planning and Environment 2015).
- 4. Consultation is required with the following public authorities and organisations under section 56(2)(d) of the Act and/or to comply with the requirements of relevant S117 Directions:
 - The NSW Office of Environment and Heritage; and
 - The local Aboriginal land council in relation to matters of Aboriginal cultural heritage.

Each public authority or organisation is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

- 5. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 6. The timeframe for completing the LEP is to be **12 months** from the week following the date of the Gateway determination.
