 - (f) Cliff Street (within the road reservation), 8 Marine Parade, 10–12 and 14–14A Pacific Street, 15 and 17 Robertson Place and 8 Salisbury Street, Watsons Bay,
 - (g) 70, 219 and 313A Edgecliff Road, 16 Fullerton Street, 19 and 21 Jersey Road, 5 Kilminster Lane, 20 Milton Avenue, 7–9 and 90 Ocean Street and 10, 84 and 86 Wallis Street, Woollahra,
