Dear Mr Walker,

Planning proposal to amend The Hills Local Environmental Plan 2012

I am writing in response to your Council's letter dated 14 May 2013 requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") in respect of the planning proposal (Amendment No. 15) to rezone land at 12 Memorial Avenue and 2, 2A and 2B Hector Court, Kellyville to B2 Local Centre, amend the minimum lot size to 600sqm and amend maximum floor space ratio and maximum building height controls on the subject land.

As delegate of the Minister for Planning and Infrastructure, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

I note that Council propose to apply a maximum floor space ratio of 1:1 and a maximum building height of 12 metres to the subject land at Memorial Avenue and Hector Court, Kellyville. Given the subject land is proposed to be rezoned for business purposes and is identified as a future local centre, Council is encouraged to consider increasing the floor space ratio and building height controls proposed on the subject land. If Council supports the above position, the planning proposal and associated maps are to be amended to reflect revised maximum floor space ratio and building height controls, prior to proceeding to public exhibition.

I have also agreed the planning proposal's inconsistency with S117 Direction 3.1 Residential Zones is of minor significance. Council is also advised that the planning proposal is considered to be consistent with S117 Direction 1.1 Business and Industrial Zones. No further approval is required in relation to these Directions.

The Minister delegated his plan making powers to councils in October 2012. It is noted that Council has now accepted this delegation. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within 12 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the department for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the

Gateway Determination

Planning proposal (Department Ref: PP_2013_THILL_008_00): to rezone land at Kellyville to B2 Local Centre and amend the developments standards applying to the subject land.

I, the Executive Director, Rural and Regional Planning at the Department of Planning and Infrastructure as delegate of the Minister for Planning and Infrastructure, have determined under section 56(2) of the EP&A Act that an amendment to The Hills Local Environmental Plan (LEP) 2012 to rezone land at 12 Memorial Avenue and 2, 2A and 2B Hector Court, Kellyville to B2 Local Centre, amend the minimum lot size to 600sqm and amend maximum floor space ratio and maximum building height controls on the subject land should proceed subject to the following conditions:

- Community consultation is required under sections 56(2)(c) and 57 of the Environmental 1. Planning and Assessment Act 1979 ("EP&A Act") as follows:
 - the planning proposal must be made publicly available for a minimum of 28 days; (a)
 - the relevant planning authority must comply with the notice requirements for public (b) exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Department of Planning & Infrastructure 2013).
- Consultation is required with the following public authorities under section 56(2)(d) of the 2. EP&A Act:
 - Transport for NSW
 - Roads and Maritime Services
 - Integral Energy
 - Sydney Water

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

- A public hearing is not required to be held into the matter by any person or body under 3. section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- The timeframe for completing the LEP is to be 12 months from the week following the 4. date of the Gateway determination.
