## Planning proposal to amend The Hills Local Environmental Plan 2012

I am writing in response to Council's letter dated 8 February 2013 requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") in respect of the planning proposal to rezone land at 488-494 Old Northern Road, Dural from RU6 Transition to B2 Local Centre and R3 Medium Density Residential and apply a maximum floor space ratio of 0.75:1 for land proposed to be zoned B2 Local Centre.

As delegate of the Minister for Planning and Infrastructure, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

I note that Council does not propose to amend the 2ha minimum lot size applicable to the subject land. Given the proposed zoning is for medium density residential and business purposes, Council is encouraged to consider amending the minimum lot size and further consider the proposed maximum floor space ratio controls allocated to land proposed for business purposes. Any decrease in minimum lot size or increase in floor space ratio controls can be added to the planning proposal and must form part of the exhibition material.

I have also agreed the planning proposal's inconsistencies with S117 Directions 1.2 Rural Zones and 7.1 Implementation of the Metropolitan Plan for Sydney 2036 are of minor significance. No further approval is required in relation to these Directions.

The Minister delegated his plan making powers to councils in October 2012. It is noted that Council has now accepted this delegation. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending LEP is to be finalised within 12 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the department for administrative purposes.

The NSW State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under s54(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

# **Gateway Determination**

**Planning proposal (Department Ref: PP\_2013\_THILL\_003\_00)**: to rezone land at Old North Road, Dural for business and residential purposes.

I, the Deputy Director General, Planning Operations and Regional Deliver at the Department of Planning and Infrastructure as delegate of the Minister for Planning and Infrastructure, have determined under section 56(2) of the EP&A Act that an amendment to The Hills Local Environmental Plan (LEP) 2012 to rezone land at 488-494 Old Northern Road, Dural from RU6 Transition to B2 Local Centre and R3 Medium Density Residential and apply a maximum floor space ratio of 0.75:1 for land proposed to be zoned B2 Local Centre should proceed subject to the following conditions:

- 1. Council is to demonstrate that the planning proposal satisfies the requirements of State Environmental Planning Policy (SEPP) 55 Remediation of Land. Council is to prepare an initial site contamination investigation report to demonstrate that the site is suitable for rezoning to the proposed zone. This report is to be included as part of the public exhibition material.
- 2. Community consultation is required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") as follows:
  - (a) the planning proposal must be made publicly available for a minimum of **28 days**; and
  - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of *A Guide to Preparing LEPs (Department of Planning & Infrastructure 2012).*
- 3. Consultation is required with the following public authorities under section 56(2)(d) of the EP&A Act and/or to comply with the requirements of relevant S117 Directions:
  - NSW Rural Fire Service (S117 Direction 4.4 Planning for Bushfire Protection)
  - Hawkesbury Nepean Catchment Management Authority
  - Office of Environment and Heritage
  - Transport for NSW Roads and Maritime Services
  - Endeavour Energy
  - Sydney Water

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

4. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).



- 5. The timeframe for completing the LEP is to be **12 months** from the week following the date of the Gateway determination.
- 6. Any decrease in minimum lot size and/or increase in floor space ratio controls endorsed by Council are to be added to the planning proposal and form part of the public exhibition material.
