## **Alteration of Gateway Determination**

## Planning proposal (Department Ref: PP\_2013\_HAWKE\_002\_00

I, the Director, Sydney Region West, at the Department of Planning and Environment, as delegate of the Greater Sydney Commission, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979* (the Act) to alter the Gateway determination dated 11 October 2013 (as since altered) for the proposed amendment to the Hawkesbury Local Environmental Plan 2012 as follows:

1. Change the description of the Planning Proposal

**from** 'to apply a minimum lot size of 2000m<sup>2</sup> and a maximum yield of 32 lots to land at 396 Bells Line of Road, Kurmond'

to apply a minimum lot size of 2000sqm, 1.0ha and 1.5ha to land at 396 Bells Line of Road, Kurmond'

2. Delete:

'condition 1'; and 'condition 2'.

3. Delete:

'condition 3'

and replace with:

new 'condition 1': 'Further community consultation is not required.'

4. Delete:

'condition 4'

and replace with:

new 'condition 2': 'Further public authority consultation is not required.'

5. Renumber:

'condition 5'

As:

'condition 3'

6. Delete:

'condition 6'

and replace with:

new 'condition 4': 'The timeframe for completing the LEP is 6 months from the week following the date of the Gateway determination'.
