#### Executive summary

In February Council resolved to prepare a Planning Proposal (PP) to address a number of general amendments to the Local Environmental Plan 2012 published in August 2012. These amendments ranged in scale and complexity from fixing minor anomalies in the Lot Size Maps to the inclusion of new local provisions. In order that the simple matters were not caught up or delayed by the more complex issues, the amendment was divided into two PPs. The Planning Proposal Minor Amendments (Attachment 1) was submitted to the Department of Planning and Infrastructure in July 2013 and was accepted through the Gateway. Having met the conditions therein, including public exhibition, the amendments can now, subject to a Parliamentary Opinion be submitted to the Minister to be made.

### Detailed report

The General Amendments were split on the basis of complexity. The "minor" amendments relate to the following:

The Planning Proposal was publically exhibited for a period of 14 days from 16<sup>th</sup> August 2013, consistent with the Gateway Determination. Council did not receive any public submission in respect to the proposal.

Consultation was also undertaken with Rural Fire Service, Office of Environment and Heritage and Department of Primary Industries (Agriculture and Minerals) in accordance with the conditions of the Gateway determination and again there were no issues raised.

The amendment involves changes to the LEP maps and the addition of caravan parks as a permissible use in the RE1 Recreation zone in the instrument. Council have sort assistance with the mapping requirements from the Department of Planning and Infrastructure. Initial contact has also been made with Parliamentary Counsel in regard to the legal drafting of the amendment. Further, as this Planning Proposal includes amendments to the same map sheets as the Bellevue Road Planning Proposal, Parliamentary Counsel propose to combine the two amendments. Once an Opinion has been received the documentation can be forwarded directly to the Minister to enable the plan to be made.

# Strategic or policy implications

The publication of the amendment means a change to the Local Environmental Plan, however, will not have a significant impact on land use generally.
