Section 73A Application to amend Mid-Western Regional Council LEP 2012- Caerleon

I am writing in response to your Council's letter dated 6 September 2013 requesting minor mapping amendments to the Mid-Western Regional Local Environmental Plan (LEP) 2012 under section 73A of the Environmental Planning and Assessment Act ("EP&A Act").

It has been determined that this is a minor amendment under section 73A of the EP&A Act and public exhibition and agency consultation is not required in this instance. Therefore, I have dispensed with conditions precedent for the making of the plan.

Further, I have considered the nature of Council's section 73A application and I have decided, as delegate of the Minister for Planning and Infrastructure, to issue an authorisation to Council to exercise delegation to make the amending LEP. The amending LEP is to be finalised within 3 months of the week following this letter.
