## REQUEST FOR EXTENSION TO TIMEFRAMES OF VARIOUS PLANNING PROPOSALS

The purpose of this letter is to seek extensions to the specified gateway timeframes for the planning proposals detailed below:

Clearview, Picton (PP\_2011\_WOLLY\_007\_00)

Gateway Determination: 8 August 2011.

Finalisation Date: 15 May 2015

Current Status:

The Clearview proposal was placed on public exhibition in July/August 2014. An objection to the planning proposal was received from the Resources and Energy Branch of the Department of Trade and Investment (DT&I) in relation to a proposed mining operation under this land in the near future. Discussions were held with DT&I and the Department of Planning to determine a way forward. A 'sunrise clause' to allow the rezoning to proceed has been proposed and is currently being considered by the Department of Planning. The DT&I are checking the progress of the mining company with their workings plan and mine subsidence management plan. Internally at Council discussions have been held in relation to a proposed voluntary planning agreement.

# Current Status:

Public exhibition of the planning proposal was undertaken in November/December 2014. Council resolved to adopt and make the planning proposal at its meeting held in February 2015. The final maps for this proposal have been held up because Council is waiting for the PTTAG Planning Proposal to be finalised as the maps are on the same mapping tile. The Department has also indicated that they are waiting for legal advice in relation to a proposed 'sunrise clause' proposed to be used in relation to an odour buffer applying to this land.

## North Silverdale Commercial, Industrial & Residential Lands (PP\_2013\_WOLLY\_005\_00)

<u>Gateway Determination:</u> 1 May, 2013

Finalisation Date: 8 May 2015

### Current Status:

A request for Gateway Determination Review and Alteration to the Gateway was submitted to the NSW Department of Planning and Environment on 13 October, 2014. The request for gateway review is intended to amend the existing gateway determination in the following manner:

- Amend the proposed zonings and minimum lot sizes in certain parts of the site that were referenced in the original gateway.
- Delete the gateway condition requiring an odour study in lieu of an established odour buffer area.

Council is currently awaiting final advice from the Department of Planning on the gateway review and in relation to legal advice regarding a proposed 'sunrise clause' for an odour buffer before the planning proposal can be further progressed.
