Dear Mr Styles,

Section 73A request to amend the Orange LEP 2011 to correct a minor mapping error for land at Leeds Parade, Orange.

I refer to your Council's letter dated 19 September 2014 requesting a minor mapping amendment to the Orange Local Environmental Plan 2011 (LEP) under section 73A of the Environmental Planning and Assessment Act (EP&A Act).

It has been determined that this is a minor amendment under section 73A of the EP&A Act and public exhibition and agency consultation is not required in this instance.

The Minister delegated his plan making powers to Councils in October 2012. It is noted that Council has accepted this delegation. I have considered the nature of Council's Section 73A application and have decided to issue authorisation for Council to exercise delegation and make this plan (**Tag 1**).

The amended Local Environmental Plan (LEP) is to be finalised within 3 months of the week following the date of this letter. Council is to request Parliamentary Counsel's Office commence drafting the instrument as soon as possible. A copy of the request should be forwarded to the Agency for administrative purposes. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's office (parliamentary.counsel@pco.nsw.gov.au) 6 weeks prior to the projected publication date.

A copy of the request should be forwarded to the Department of Planning and Environment (westernregion@planning.nsw.gov.au) for administrative purposes.

The amended LEP maps and GIS data is to be uploaded to the Departments FTP site at ttp://lepup:lep_upload@203.3.194.247/ and the map information emailed to: pcgis@planning.nsw.gov.au and a copy to westernregion@planning.nsw.gov.au.
