The following uses are proposed to be redrafted: Advertisements and advertising structures Change of use of premises (to allow a change of use from a restaurant to another kind of restaurant - we get a lot of these) Horse stabling

In doing this list I have noticed that Jazmin has deleted the exempt provisions for outdoor eating. As roads in the Shire are zoned road (zone 22 Arterial Road, zone 23 Road) and food shops and restaurants are not permissible use in these zones, these provisions should stay.
