Hi Luke,

I apologise for the delay in getting back to you in relation to this planning proposal.

On review of the title information, we have discovered an inconsistency between our system and that of Land and Property Information with respect to Lot 1 DP 604567 in Regatta Avenue, Ballina. In summary, the LPI system does not appear to recognise this lot and we have been unable to confirm the status of the land now that we have uncovered this inconsistency. Given this, we would like to proceed with the Gateway determination and planning proposal excluding this lot from the process (we would like to continue to include Lot 2 DP 604567).

On the matter of interests, Council does not propose to change any interests currently held in the land parcels through the reclassification process. We do, however, propose removal of public reserve notations from the titles of several land parcels should the reclassification proceed to completion. We are seeking to proceed through to the public exhibition and the public hearing processes to enable the Council to further consider these public land notations on the titles.

I have attached a copy of the title search information for the parcels with public reserve notations for the Department's information. The relevant land parcels are Lot 2 DP 850774 (site 8 in the planning proposal), Lot 52 DP 842077 (site 8), Lot 29 DP 230062 (site 17) and Lot 47 DP 240657 (site 3).

Please let me know if you would like to discuss further or need any additional information to progress the Gateway determination.
