## **Alteration of Gateway Determination**

## Planning proposal (Department Ref: PP\_2015\_BLUEM\_001\_00)

I, the Director Sydney Region East, at the Department of Planning and Environment as delegate of the Greater Sydney Commission, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979* (the Act) to alter the Gateway determination dated 3 September 2015 for the proposed amendment to the Blue Mountains Local Environmental Plan 2015 as follows:

1. Delete:

condition 2

and replace with:

new condition 2 "In accordance with Section 117 Direction 6.2 – Reserving Land for Public Purposes, Council is to obtain endorsement from NSW Trade and Investment – Crown Lands for the proposed E2 – Environmental Conservation zone at 7-19 Lawsons Long Alley, Mount Victoria. If Council is unable to obtain approval, this site should be removed from the planning proposal."

2. Delete:

condition 4

and replace with:

new condition 4 "Council is to remove the proposed rezoning of 111 Mort Street, Katoomba from the planning proposal and Addendum to Item 3 due to the absence of satisfactory Preliminary Site Investigations for contamination from Sydney Water under State Environmental Planning Policy 55 – Remediation of Land".

3. Insert:

new condition 10

"Council is to update the planning proposal for land at 70 Great Western Highway, Woodford, to retain the zone E4 – Environmental Living, as requested by Sydney Trains. Council is also to update the planning proposal for land at 70A Great Western Highway, Woodford, to zone RE1 – Public Recreation, as endorsed by Roads and Maritime Services." 4. Insert:

new condition 11

"Council is to update the planning proposal to remove the SP2 – Infrastructure zoning for land at 690A Great Western Highway, Faulconbridge, and replace with E4 – Environmental Living zone, as endorsed by Sydney Trains."

5. Insert:

new condition 12

"Council is to update the planning proposal to include land identified as RP-SP01 St Columba's Elmhurst Precinct with appropriate development controls for the land."
