Planning Proposal – Albury Showground

At the Council meeting held on Monday 25 February 2019, AlburyCity resolved to forward the above Planning Proposal to the NSW Department of Planning and Environment and request a Gateway Determination, including the delegation of plan making powers, so as to enable public exhibition to commence.

The Planning Proposal is based on a detailed investigation and Master Plan for the Albury Showground site. NSW Crown Lands (landowner) and AlburyCity agreed to undertake a review of the Albury Showground site to identify the activities and land uses that support the long term viability of the site. This included consideration to the zoning of the land and permissible activities under the *Albury Local Environmental Plan 2010* (ALEP 2010).

The ongoing activities and operations at the Albury Showground are not consistent with the objectives of the current R1 *General Residential* Zone. The R1 *General Residential* Zone objectives are aimed at encouraging residential and compatible uses and protecting the amenity of residents. The historic uses of this site would generally be considered inconsistent with these aims. The existing zoning is an anomaly associated with the transition from a broader general open zone adopted to the more prescriptive Standard Instrument LEP.

Accordingly, the Planning Proposal seeks to rezone Albury Showground from R1 *General Residential* Zone to RE2 *Private Recreation* Zone. This will assist land use outcomes consistent with recommendations contained within the Albury Showground Master Plan 2018.
