## **Alteration of Gateway Determination**

## Planning proposal (Department Ref: PP\_2015\_CLARE\_001\_00)

I, the General Manager, Northern Region at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979 (EP&A Act)* to alter the Gateway determination dated 16 January 2015 for the proposed amendment to the Clarence Valley Local Environmental Plan 2011 as follows:

1. Change the description of the Planning Proposal

<u>from</u> Planning proposal to amend Clarence Valley LEP 2011 to include land affected by flood hazard at Glenreagh on the Flood Planning Map and revise the map detail for land within the Clarence River floodplain.

**to** Planning proposal to amend Clarence Valley LEP 2011 to revise the Flood Planning Map for land within the Clarence River floodplain.

- Delete condition 6.
- 3. Delete condition 7 and replace with a new condition 6 as follows:
  - 6. The Local Environmental Plan is to be completed by 23 January 2016.
