RE: REQUEST FOR GATEWAY- DRAFT PLANNING PROPOSAL TO EXPAND THE OPTIONS FOR BOUNDARY ADJUSTMENTS IN THE RURAL ZONES OF THE WELLINGTON LEP 2012. PROPOSED WELLINGTON LEP 2012 AMENDMENT No. 4.

At its meeting held 17 December 2014, Council considered a report recommending three draft planning proposals proceed to request for Gateway determination.

Council resolved, pursuant to Section 56 of the Act, to forward all three proposals to the Department of Environment and Planning requesting Gateway.

Given the processing times of each plan will vary, Council has divided the proposals into three separate applications for Gateway.
