#### 8: Reference: Land Reservation Acquisition Map

#### **Objectives or intended outcomes**

The removal of a number of reservations for road widening and open space for Council acquisition that are no longer required, as the acquisitions have taken place.

#### Explanation

Amendment of the Land Reservation Acquisition Map as follows:

- Remove road widening reservation from front portions of 15 and 17 Macquarie St. and include in B4 Mixed Use Zone. (refer to Attachment 1).
- Remove road widening reservation from 1 Macquarie Street and zone B4 Mixed Use. (refer to Attachment 2)
- Remove road widening reservation from front portion of 60 Campbell St., show as unzoned and remove height and floor space ratio from land. (refer to Attachments 3 to 6).
- Remove the Regional Open Space reservation applying to 182B, 184B, 186B & 188B George Street Parramatta. (refer to Attachment 7)
