Planning Proposal (PP_2015_NARRO_005_00) to amend Narromine LEP 2011 – Lot 145 DP 755110 Tomingley Cemetery Road, Tomingley

I am writing in response to your Council's letter dated 28 April 2015 requesting a Gateway determination under section 56(1) of the Environmental Planning and Assessment Act 1979 (EP&A Act) with respect to the planning proposal to amend the Narromine Local Environmental Plan 2011 to rezone land and reduce the minimum lot size at Lot 145 DP 755110, Tomingley Cemetery Road, Tomingley.

As a delegate of the Minister for Planning, I have determined the planning proposal should proceed subject to the conditions in the attached Gateway determination (Attachment 1).

The Minister delegated his plan making powers to Councils in October 2012. It is noted that Council has accepted this delegation. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan (Attachment 2).

The amending Local Environmental Plan (LEP) is to be finalised within 12 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office (parliamentary.counsel@pco.nsw.gov.au) 10 weeks prior to the projected publication date.

A copy of the request should be forwarded to the Department of Planning and Environment (westernregion@planning.nsw.gov.au) for administrative purposes.

The amended LEP maps and GIS data is to be uploaded to the Departments FTP site at ttp://lepup:lep_upload@203.3.194.247/ and the map information emailed to: pocgis@planning.nsw.gov.au and a copy to westernregion@planning.nsw.gov.au



The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

In accordance with "A guide for the preparation of local environmental plans", Attachment 5 – Delegated plan making reporting template (Attachment 3) is enclosed for Council's information. Table 2 of the attachment is to be completed and forward to westernregion@planning.nsw.gov.au when requesting the planning proposal to be notified.

Gateway Determination

Planning proposal (Department Ref: PP_2015_NARRO_005_00): to rezone land from zone RU1 Primary Production to R5 Large Lot Residential and amend the minimum lot size from 400 hectares to 5 hectares at Lot 145 DP 755110 Tomingley Cemetery Road, Tomingley.

I, the General Manager, Western Region at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the EP&A Act that an amendment to the Narromine Local Environmental Plan 2011 (LEP) to rezone land and amend the minimum lot size at Lot 145 DP 755110 Tomingley Cemetery Road, Tomingley should proceed subject to the following conditions:

- 1. Prior to public exhibition the planning proposal is to be amended to include an adequate locality map identifying Lot 145 DP 755110 Tomingley Cemetery Road, Tomingley.
- 2. Community Consultation is required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 (EP&A Act) as follows:
 - (a) the planning proposal must be made publicly available for a minimum of **28 days**; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of *A Guide to Preparing LEPs (Department of Planning & Infrastructure 2013)*.
- 3. Consultation is required with the following public authorities under section 56(2)(d) of the EP&A Act 1979 and/or to comply with the requirements of the relevant Section 117 Direction:
 - NSW Rural Fire Service
 - NSW Department of Primary Industries Office of Water
- 4. Council is to ensure that the planning proposal satisfies the requirements of State Environmental Planning Policy (SEPP) 55 Remediation of Land. An initial site contamination investigation report may be required to demonstrate that the land is suitable for rezoning to the proposed zone. Any information obtained from preliminary review of the subject land, or from initial site contamination investigation report shall accompany submission of the planning proposal under section 59 of the EP&A Act 1979.
- 5. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 6. Prior to the submission of the Planning Proposal under section 59 of the EP&A Act 1979 the relevant Land Zoning Map and Lot Size Map that apply to the subject land are to be prepared compliant with the Department's 'Standard technical requirements for LEP maps'.



7. The timeframe for completing the LEP is to be **12 months** from the week following the date of the Gateway determination.
