1.0 INTRODUCTION

Council has prepared the Bathurst Region Heritage Study (adopted 21 March 2007), the Bathurst Region Urban Strategy (adopted 21 March 2007) and the Bathurst Region Rural Strategy (adopted 10 December 2008). The aim of these three projects was to provide the broad framework for the preparation of a comprehensive Local Environmental Plan (LEP) for the Bathurst Regional local government area (LGA).

This document provides a summary of the Bathurst Region Heritage Study. A full copy of the Heritage Study is available from Council's Environmental Planning and Building Services Department.

1.1 <u>Aims and Objectives</u>

The Bathurst Region Heritage Study is a community based heritage study which has sought to locate heritage items and places and explain why they are significant through the use of historic themes and statements of significance. The study has sought to recommend ways of managing and conserving that significance to support:

- a community's sense of identity its beginnings, its present and its potential,
- the future management of the heritage items and places,
- future education programs making the community's heritage assets better known, understood and appreciated, and
- future heritage tourism strategies.

1.2 Study Area

The study has investigated existing listed heritage places throughout the new Bathurst Regional Council LGA, excluding the Bathurst City Conservation Area, but including places previously recorded in the heritage studies of the former Evans Shire and Bathurst City Councils. It also investigated historic places nominated by the community through a Council wide appeal to the public and through community village consultations.

1.3 <u>Acknowledgements</u>

Bathurst Regional Council acknowledges the funding provided by the NSW Heritage Office (Department of Planning) to undertake this Study. Council has also invested considerable funds and resources to complete the project.

The Study was written and coordinated by Council's Heritage Advisor, Barbara Hickson in conjunction with Council staff. Council also acknowledges the work and assistance of Dr Robin McLachlan, the historian, the Bathurst and District Historical Society and the Study Working Party.

2.0 THE STUDY PROCESS

2.1 Identifying Sites

Potential heritage places were examined though site visits, checked against existing lists, and researched for their cultural significance before deciding if they were places of heritage significance that should be listed on the future Bathurst Regional

comprehensive Local Environment Plan. (LEP). The team that visited sites consisted of Council's heritage advisor Barbara Hickson, coordinator of the study, historian Dr. Robin McLachlan, and senior strategic planner Sinclair Croft, although not all visited each site.

During the site visits the following information was collected:

- photographs
- GPS readings
- Description of the place
- Any information provided by the property owners

The Coordinator and Council's Planner completed a State Heritage Inventory (SHI) form for each site/place to be included in the study. This form includes the following information:

- Property description and address
- Statement of Significance
- Assessment of the 7 criteria for listing as defined by the NSW Heritage Office
- Physical description and condition of the place/site
- Images

Over 530 inventory forms have been completed and are available for individual sites/places by contacting Council's Senior Strategic Planner, Sinclair Croft.

Information collected was further reviewed by the Study Working Party.

The SHI database will be retained by the Council and will continue to be updated. Many histories included in this database were provided by the Bathurst & District Historical Society and all SHI data information has been sent back to owners for their information and feedback.

The present Bathurst Regional (Interim) LEP 2005 has 131 listed items although this number does not reflect the total pool of items. Many of the 'items' include groupings of buildings which have not been separately listed. There are more items of heritage significance included within the Bathurst City Conservation Area that are not listed. The former Evans Shire Council area had only one item which is now listed on the Bathurst Regional (Interim) LEP 2005.

The Heritage Study recommended an additional 169 items be placed on the new comprehensive LEP. In addition new or modified conservation areas were also recommended in many of the village locations which will contain many more places of significance. See below for management recommendations and how they are being implemented into the LEP and DCP.

2.2 <u>Thematic History</u>

Historian Dr. Robin McLachlan was engaged to write a 'thematic history' of the Bathurst Region. This is a history based on story lines such as 'transport' or 'mining'. It provides a methodology for looking at the history of an area and seeking to identify if the places listed provide 'good examples' to illustrate the thematic history, e.g.

stone bridges between Sofala and Wallaby Rocks on the Hill End Road illustrate transport history.

The thematic history includes 38 themes as follows:

2.3 <u>Aboriginal Heritage</u>

An Aboriginal liaison officer was engaged to carry out the Aboriginal component of the Study. Substantial data was identified but this component has not been completed, and the study recommends further Aboriginal studies to be undertaken into the future. The Study makes broad recommendations for the protection of Aboriginal Cultural Heritage within the Local Government Area including:

- Updating of data collected in conjunction with the Department of Environment and Conservation.
- A more detailed Aboriginal heritage study be completed in the future.
- That planning controls be introduced which protect areas of high biodiversity conservation value as these areas are likely to contain sites of Aboriginal cultural heritage (i.e. the Study supports the recommendations of the Bathurst Region Rural Strategy with respect to the protection of the region's biodiversity).

Note that since the completion of the Heritage Study the Central West Catchment Management Authority has commenced a study to identify the likelihood of potential additional Aboriginal site within the LGA. Should this study identify additional sites that should be included on the LEP as heritage items appropriate amendments to the LEP will be proposed.

3.0 MANAGEMENT RECOMMENDATIONS AND IMPLEMENTATION ONTO LEP/DCP

The main recommendations of the Heritage Study are summarised below.

4.0 BATHURST CONSERVATION AREA REVIEW

Subsequent to the Heritage Study Council has undertaken the Bathurst Conservation Area Review. The key recommendations of the Bathurst Conservation Area Review are summarised below.
