## Planning proposal (Department Ref: PP\_2015\_RICHM\_001\_00)

I, the General Manager, Northern Region at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979* (the Act) to alter the Gateway determination dated 26 June 2015 (as altered) for the proposed amendment to the Richmond Valley Local Environmental Plan 2012 as follows:

1. Change the description of the Planning Proposal:

**from** "... amendments to provisions for the RU1 Primary Production, R5 Large Lot Residential and E3 Environmental Management Zones in the Richmond Valley Local Environmental Plan (LEP) 2012 and to amend Schedule 2 of the LEP to allow "special events" on public land as exempt development."

to "... amendments to provisions for the RU1 Primary Production, R5 Large Lot Residential and E3 Environmental Management Zones in the Richmond Valley Local Environmental Plan (LEP) 2012 and to amend Schedule 2 of the LEP to allow "special events" on public land, except that land zoned E2 Environmental Conservation or E3 Environmental Management, as exempt development."

2. Delete Condition 5:

"5. Further community consultation is required under sections 56(2)(c) and 57 of the Act as follows:

- a. the amended planning proposal must be made publicly available for a minimum of 28 days; and
- b. the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of *A Guide to Preparing LEPs* (*Department of Planning and Infrastructure 2013*)."
- 3. Delete Condition 6:

6. Further consultation is required with the following public authorities under section 56(2)(d) of the Act and/or to comply with the requirements of relevant Section 117 Directions:

- NSW Department of Primary Industries in relation to potential impacts on agricultural activities;
- NSW Rural Fire Service; and
- Office of Environment and Heritage.



Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.
