Planning proposal to amend Richmond Valley Local Environmental Plan 2012

I am writing in response to your Council's letter dated 19 June 2015 requesting a Gateway determination under section 56 of the *Environmental Planning and Assessment Act 1979* (the Act) in respect of the planning proposal to make amendments to provisions for the RU1 Primary Production, R5 Large Lot Residential and E3 Environmental Management Zones in the Richmond Valley Local Environmental Plan (LEP) 2012 and to amend Schedule 2 of the LEP to allow "special events" on public land as exempt development.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

I have also agreed the planning proposal's inconsistencies with S117 Directions 1.2, 4.1 and 4.3 are justified in accordance with the terms of the directions. No further approval is required in relation to these Directions.

Council may still need to obtain the agreement of the Department's Secretary to comply with the requirements of S117 Direction 4.4 after consultation with the NSW Rural Fire Service. Council should ensure this occurs prior to the plan being made.

Plan making powers were delegated to councils by the Minister in October 2012. It is noted that Council has accepted this delegation. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending LEP is to be finalised within 9 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet

these commitments, the Minister may take action under section 54(2)(d) of the Act if the time frames outlined in this determination are not met.

Gateway Determination

Planning proposal (Department Ref: PP_2015_RICHM_001_00): to make amendments to provisions for the RU1 Primary Production, R5 Large Lot Residential and E3 Environmental Management Zones in Richmond Valley Local Environmental Plan (LEP) 2012 and to amend Schedule 2 of the LEP to allow "special events" on public land as exempt development.

I, the General Manager, Northern Region at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that amendments to provisions in Richmond Valley Local Environmental Plan (LEP) 2012 for the RU1 Primary Production, R5 Large Lot Residential and E3 Environmental Management Zones and to amend Schedule 2 of the LEP to allow "special events" on public land as exempt development, should proceed subject to the following conditions:

1. Community consultation is required under sections 56(2)(c) and 57 of the Act as follows:
 - (a) the planning proposal is classified as routine as described in *A Guide to Preparing LEPs (Department of Planning and Environment 2013)* and must be made publicly available for a minimum of **28 days**; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of *A Guide to Preparing LEPs (Department of Planning and Environment 2013)*.
2. Consultation is required with the following public authorities under section 56(2)(d) of the Act and/or to comply with the requirements of relevant Section 117 Directions:
 - NSW Department of Primary Industries in relation to potential impacts on agricultural activities;
 - NSW Rural Fire Service; and
 - Office of Environment and Heritage.

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

3. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).



4. The timeframe for completing the LEP is to be **9 months** from the week following the date of the Gateway determination.
