RE: SUBMISSION OF A PLANNING PROPOSAL DRAFT LIVERPOOL LOCAL ENVIRONMENTAL PLAN (AMENDMENT NO. 7) - LOTS 1, 2 AND 3 DP 239468 PLEASURE POINT

Pursuant to section 56 of the Environmental Planning and Assessment Act 1979 (EP&A Act), Council is forwarding a planning proposal for Draft Liverpool Local Environmental Plan 2008 (Amendment No. 7), seeking gateway determination. The purpose of Draft Amendment No. 7 is to rezone Lots 1, 2 and 3 DP 239468 Pleasure Point from Zone E3 Environmental Management to Zone R2 Low Density Residential.

At its meeting on 23 November 2009, Council resolved to:

- Prepare and exhibit an amendment to the Liverpool Local Environmental Plan (Amendment No. 7) to rezone portions of Lots 1, 2 and 3 DP 239468 from E3 Environmental Management to R2 Low Density Residential.
- Forward a copy of the planning proposal to the Department of Planning, seeking gateway determination and following that proceed with agency and public consultation.

A copy of the Planning Proposal prepared in accordance with 'A guide to preparing planning proposals', the aforementioned report to Council on this matter, and amending maps to Liverpool Local Environmental Plan 2008 is enclosed for your consideration.
