Re: Planning Proposal for Seniors Living in Precinct D of Mater Dei Residential Area

I am writing in response to your Council's letter dated 19 January 2010 requesting a Gateway Determination under section 56 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") in respect of the planning proposal to amend Schedule 1 of the draft Camden Local Environmental Plan 2010 to include a seniors housing type development as a permissible development within Precinct D of the Mater Dei site (Lot 1 DP 217570).

As delegate of the Minister for Planning, I have now determined that the planning proposal should not proceed for the reasons outlined in the attached Gateway Determination.

Although I am not in a position to deliver a positive Gateway Determination at this stage, I would be prepared to consider a Planning Proposal which proposed to allow the development of the site within an appropriate zone. It is not considered appropriate to allow seniors housing via an amendment to Schedule 1 of the draft Camden Local Environmental Plan 2010 on land that is proposed to be zoned E4 Environmental Living Zone. Any revised planning proposal should be discussed with both the Department Environment, Climate Change and Water and the Rural Fire Service prior to submission to the Department. Specifically, the Department would require further information concerning the potential risks associated with bush fire events and the development of a Seniors Living precinct.
