Please find attached a request from Council to make an amendment to Murray LEP 2011 in accordance with s73A of the *Environmental Planning and Assessment Act 1979.* 

The amendment relates to rectifying an error identified on the Land Zoning Map 006B of Murray LEP 2011 in respect to a strip of land in Maiden Smith Drive, Moama.

The land has been zone Large Lot Residential however the reference on the Land Zoning Map is 'W2' rather than 'R5'.



Mr Chairman and Councillors,

I wish to report as follows -

# CLAUSE 1. MURRAY LEP 2011 S73A AMENDMENT TO RECTIFY MAPPING ERROR

Council staff have identified an error on the Land Zoning Map '6B' of Murray LEP 2011. The error is in respect to the strip of land in Maiden Smith Drive zoned R5 Large Lot Residential. The reference to this land on the Land Zoning Map is W2 which refers to the Recreational Waterways zone (see below). The reference should be 'R5'.



The error was made by the Department of Planning and Infrastructure when they made changes to draft LEP in respect to Maiden Smith Drive prior to making Murray LEP 2011.

To rectify obvious errors such as this Council can propose to have the LEP amended using s73A of the Environmental Planning Assessment Act 1979.

# 73A Expedited amendments of environmental planning instruments

- (1) An amending environmental planning instrument may be made under this Part without compliance with the provisions of this Part relating to the conditions precedent to the making of the instrument if the instrument, if made, would amend or repeal a provision of a principal instrument in order to do any one or more of the following:
  - (a) correct an obvious error in the principal instrument consisting of a misdescription, the inconsistent numbering of provisions, a wrong crossreference, a spelling error, a grammatical mistake, the insertion of obviously missing words, the removal of obviously unnecessary words or a formatting error,

The use of this clause under the LEP to rectify an obvious error alleviates the need to prepare a 'planning proposal' and follow the normal procedure for amending an LEP through the 'gateway system'.

It is recommended that Council submit a proposal to amend the Murray LEP 2011 under s73A of the Environmental Planning and Assessment Act 1979. This is to correct an obvious error in the current plan. The amendment will have the reference on the land mapped as being R5 Large Lot Residential in Maiden Smith Drive on Land Zoning sheet 6B changed from 'W2' to the correct reference 'R5'.

#### **Recommendation**

That Council submit a proposal to amend the Murray LEP 2011 in accordance with s73A of the Environmental Planning and Assessment Act 1979 in order to have the reference on land mapped as being R5 Large Lot Residential in Maiden Smith Drive on Land Zoning sheet 6B changed from 'W2' to the correct reference 'R5'
