Planning Proposal (PP_2016_FEDER_001_00) to amend Corowa Local Environmental Plan 2012 (Amendment 11) to rezone certain land at Corowa, Howlong and Mulwala town centres from zone B2 – Local Centre to zone B4 – Mixed Use

I am writing in response to Council's request received on 28 June 2016 requesting a Gateway determination under section 56 of the *Environmental Planning and Assessment Act 1979* in respect of the planning proposal to rezone certain land at Corowa, Howlong and Mulwala town centres from zone B2 – Local Centre to zone B4 – Mixed Use.

As delegate of the Minister for Planning, I have now determined that the planning proposal should proceed subject to the conditions in the attached Gateway determination (Attachment 1).

The Minister delegated plan making powers to Councils in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan (Attachment 2).

The amending Local Environmental Plan (LEP) is to be finalised within 12 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office (parliamentary.counsel@pco.nsw.gov.au) 10 weeks prior to the projected publication date.

A copy of the request should be forwarded to the Department of Planning and Environment's Western Region office (westernregion@planning.nsw.gov.au) for administrative purposes.

All related files for the LEP Amendment, including PDF Maps, Map Cover Sheet, Planning Proposal document, section 59 Reporting and GIS data, if available, must be submitted to the Department via the Planning Portal Website at https://www.planningportal.nsw.gov.au/planningtools/online-submission-planning-data. To submit the data, Council is required to create an account and log in using these details.

In accordance with 'A guide for the preparation of local environmental plans' Attachment 5 – Delegated plan making reporting template (Attachment 3) is enclosed for Council's information.

Table 2 of the attachment is to be completed and included in Council's section 59 submission and uploaded to the Planning Portal when requesting the planning proposal be finalised.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the *Environmental Planning and Assessment Act*, 1979 if the timeframes outlined in this determination are not met.

Gateway Determination

Planning proposal (Department Ref: PP_2016_FEDER_001_00): to amend the Corowa Local Environmental Plan 2012 to rezone certain land at Corowa, Howlong and Mulwala town centres from zone B2 – Local Centre to zone B4 – Mixed Use.

I, the Acting Director Regions, Western at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the Environmental Planning and Assessment Act, 1979 that the amendment to the Corowa Local Environmental Plan 2012 (LEP) to rezone certain land at Corowa, Howlong and Mulwala town centres from zone B2 – Local Centre to zone B4 – Mixed Use should proceed subject to the following conditions:

- 1. Community consultation is required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 as follows:
 - (a) the planning proposal must be made publicly available for a minimum of 28 days; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Department of Planning & Infrastructure 2013).
- 2. Consultation is required with Roads and Maritime Services under section 56(2)(d) of the Environmental Planning and Assessment Act 1979. Roads and Maritime Services are to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.
- 3. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the Environmental Planning and Assessment Act, 1979. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 4. Prior to submission of the planning proposal under Section 59 of the Environmental Planning and Assessment Act, the final LEP maps must be prepared and be compliant with the Department's 'Standard Technical Requirements for Spatial Datasets and Maps' (2015).
 - 5. The time frame for completing the LEP is to be 12 months from the week following the date of the Gateway determination
