Planning Proposal PP_TAMW_003_00 to amend Council Local Environmental Plan 2010

I am writing in response to Council's request for a Gateway determination under Section 56 of the *Environmental Planning and Assessment Act 1979* (the Act) and additional information received on 25 January 2018 in respect of the Planning Proposal to reduce the existing minimum lot size for part of a *R5 Large Lot Residential* area on part of Lot 18, DP 1199163, Oakland Drive, Nemingha from 2 hectares to 1 hectare.

As delegate of the Minister for Planning, I have now determined the Planning Proposal should proceed subject to the conditions in the attached Gateway determination.

I have also agreed, as delegate of the Secretary, the Planning Proposal's inconsistency with Section 117 Direction 5.10 Implementation of Regional Plans is justified in accordance with the terms of the Direction. No further approval is required in relation to this Direction.

Council may still need to obtain the agreement of the Department's Secretary to comply with the requirements of relevant Section 117 Directions 4.4 Planning for Bushfire Protection. Council should ensure this occurs prior to the plan being made.

Plan making powers were delegated to Councils by the Minister in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within 9 months of the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under Section 54(2)(d) of the Act if the time frames outlined in this determination are not met.

Gateway Determination

Planning Proposal (Department Ref: PP_2018_TAMW_003_00): to reduce the existing minimum lot size for part of a R5 Large Lot Residential area on part of Lot 18, DP 1199163, Oakland Drive, Nemingha from 2 hectares to 1 hectare.

I, the Director Regions, Northern, at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act, 1979* (the Act) that an amendment to the Tamworth Regional Council Local Environmental Plan (LEP) (2010) to reduce the existing minimum lot size for part of a *R5 Large Lot Residential* area on part of Lot 18, DP 1199163, Oakland Drive, Nemingha from 2 hectares to 1 hectare subject to the following conditions:

- 1. Prior to community or agency consultation, the planning proposal is to be amended to:
 - (a) include an amended minimum lot size map which removes all Zone E3 Environmental Management land from the area proposed to have an amended minimum lot size;
 - (b) amend the discussion relating to s117 Direction 5.1 to correctly refer to 5.10; and
 - (c) update Part 6 'Project Timeline' to correctly reflect the Gateway determination date.
- 2. Community consultation is required under sections 56(2)(c) and 57 of the Act as follows:
 - (a) the planning proposal must be made publicly available for a minimum of 28 days; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in Section 5.5.2 of *A guide to preparing local environmental plans* (Department of Planning and Environment 2016).
- 3. Consultation is required with the following public authorities under section 56(2)(d) of the Act and to comply with the requirements of relevant Section 117 Directions:
 - NSW Department of Primary Industries Water
 - Office of Environment and Heritage
 - NSW Rural Fire Service



Each public authority is to be provided with a copy of the Planning Proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

- 4. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 5. The timeframe for completing the LEP is to be **9 months** following the date of the Gateway determination.
