## Planning Proposal PP\_2016\_PARRA\_001\_00 – Alteration of Gateway Determination

I refer to your letter seeking an extension of time to complete Planning Proposal PP\_2016\_PARRA\_001\_00 to rezone the subject land to B4 Mixed Use; increase the maximum height of buildings to 31m; increase the maximum floor space ratio to 2.25:1; and, exclude the wintergarden floor area from the FSR calculation for proposed units fronting Woodville Road at 246-264 Woodville Road, 2-4, 8-8A and 14-16 Lansdowne Street and 19 Highland Street, Merrylands.

In accordance with the agreement reached at the meeting between the Department's Accelerated Rezoning Team and Council staff on 12 October 2017, I have determined as the delegate of the Greater Sydney Commission, in accordance with section 56(7) of the *Environmental Planning and Assessment Act 1979*, to alter the Gateway determination dated 24 June 2016 for PP\_2016\_PARRA\_001\_00 as indicated in the table below:

To amend Parramatta Local Environmental Plan 2011 to rezone land at 246-264 Woodville Road, 2-4, 8-8A and 14-16 Lansdowne Street and 19 Highland Street, Merrylands to B4 Mixed Use, increase the maximum height of buildings to 31m, increase the maximum floor space ratio to 2.25:1 and enable wintergardens within residential development fronting Woodville Road that exclude the wintergarden floor area from the FSR calculation.
